



## TMLP Participates in DOER MLP Solar Rebate Program for Residential Customers

**TMLP** customers who want to install solar panels for home energy use can now apply for a generous incentive through the MLP Solar Program. **TMLP** has pledged \$350,000, which the **Department of Energy Resources (DOER) will match, for a potential total of \$700,000 in program funds.** The MLP Solar Program will award \$1.20 per watt total for approved projects, with **TMLP** and the DOER both providing a matching contribution of \$.60 for systems up to 7.5 kW. Awards will be dispensed on a first come, first served basis to solar projects that meet specific TMLP & DOER requirements.

The MLP Solar Program provides an up-front award, making it different from the recently-expired Solar Renewable Energy Credit (SREC) program. Until the end of November 2018, SREC program participants received their award quarterly, spread over 10 years. **TMLP** is participating in this remarkable incentive program to make solar technology more affordable for our customers to adopt robust renewable energy sources.

## **Program Highlights**

•Provides \$1.20 per watt of installed solar production (\$.60 per watt from TMLP and \$.60 per watt from the DOER) with the maximum rebate reached at 7.5 kW.

For example: Systems sized for 7.5 kW of solar energy production (direct current) will be eligible for a \$9,000 rebate (\$4,500 from TMLP + \$4,500 from DOER)

- •Rebates will equal no more than 1/2 the installed cost of any system
- •Participating customers will also have financing options available through the Mass Solar Loan program, with low-interest, fixed rates and support for income qualified residents.
- •Only customers with renewable generation systems approved by **TMLP & DOER** will qualify to receive the rebate.
